Federal Court Strikes Down New Salary Threshold for Exempt Employees



An employee is exempt from overtime if they meet certain conditions and an income threshold as outlined in the Fair Labor Standards Act.

In January 2025, the salary threshold would have increased from \$43,888 to \$58,656.

But a federal court has struck down the rule.

The court also struck down the July 1, 2024 rule that had already taken effect and the "escalator" provision that would have raised the threshold every 3 years has also been deemed unlawful. Now the exemption salary threshold is back to \$684 per week or \$35,568 annually.

Annual Reports

Did you know there's more than one annual report? There are actually three different reports for different audiences:

- 1. The State report to the Office of Commonwealth Libraries that libraries complete in the first quarter of the year annually. Coming up soon!
- 2. The requirement for libraries to report to their municipalities annually, as laid out in library regulations.
- 3. And new this year: The <u>annual report to the Department of State</u>, which retains an organization's business status in Pennsylvania. This will begin in 2025 and replaces the decennial (10-year form) and will need to be completed every year.
